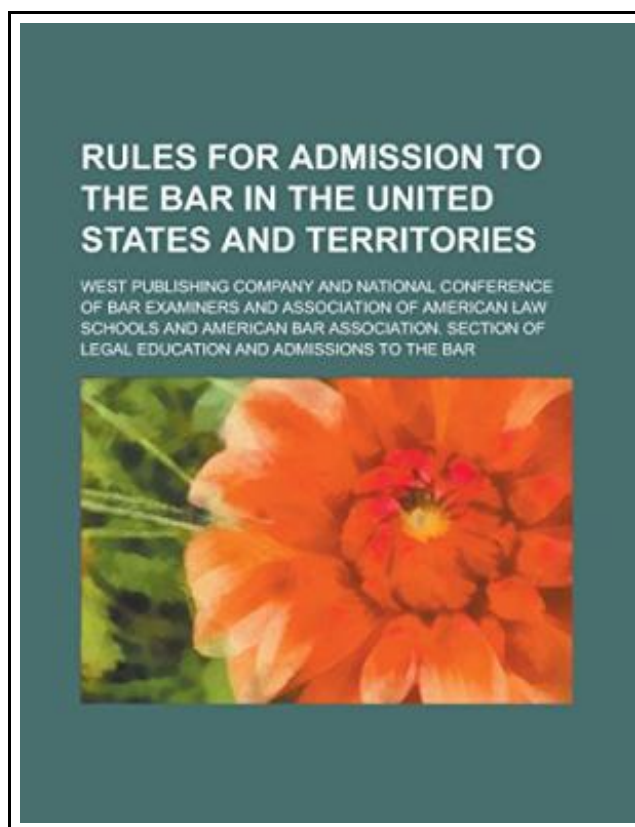

These preliminary examinations are held in each county of the state on the first Friday and Saturday of February, May, and October, at the times and places at which county examinations are held for teachers licenses. Information regarding the exact times and places may be obtained from the superintendent of schools of the respective counties. Each candidate will be examined upon ten subjects (of which Composition and Orthography must be two) that he may select from the following list: Advanced History of the United States, General History, Advanced Arithmetic, Advanced Algebra, Plane Geometry, Physiology, Grammar, Composition, Orthography, Geography, Civics, Physics, Latin, French, Bookkeeping, Business Practice. The county Board of Examiners will notify the State Superintendent of Public Instruction of those who pass the examination, whereupon the Superintendent will issue certificate of that fact to the successful candidate for presentation to the clerk of the Supreme Court, as above required. Term of Study. A regular clerkship for a term of three years shall be served with some practicing attorney of the court before entering upon the examination. Any portion of the time, not to exceed 27 months, may be spent in regular attendance at a reputable law school. The applicant shall file with the clerk of the Supreme Court, at the commencement of the clerkship, a certificate of the attorney that the clerkship has begun.
