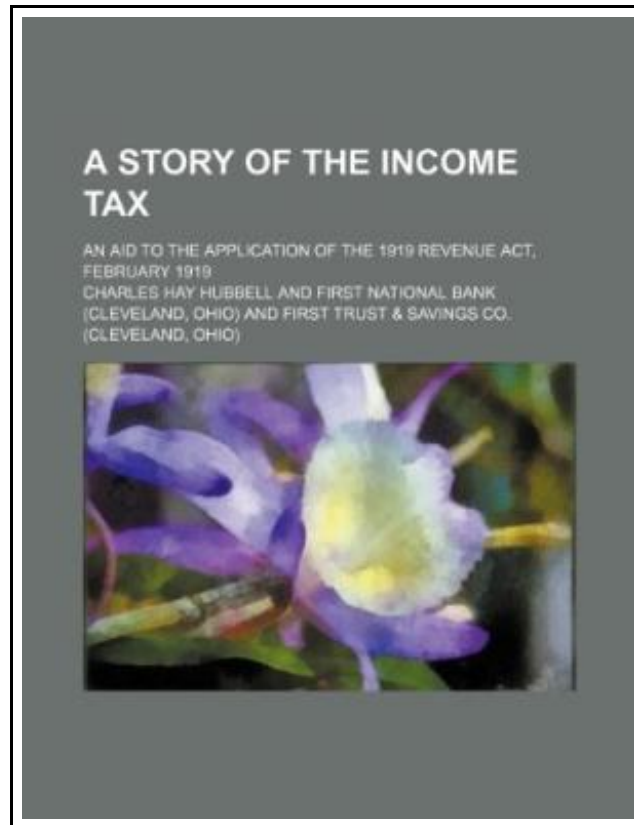

This office is in receipt of your letter of the 19th instant, in which you ask a ruling of this office as to how payments made under the bonus system or profit-sharing plans may be treated by corporations in making their returns of annual net income. This office has consistently held and still holds that in cases where these increased compensations, denominated as bonuses or profit sharings, are paid to the employees pursuant to a contract as between the employees and the corporation, the amounts so paid will be considered an ordinary and necessary expense of operation of business, and as such will constitute an allowable deduction from gross income of the corporation making such payments. If, however, there is no contractual relation between the employee and the employer by reason of which the employee could enforce his claim for the additional compensation, it is held that these payments are gratuities on the part of the corporation and as such are not allowable deductions from gross income. (Letter to the Alexander Hamilton Institute, signed by Acting Commissioner Robert Williams, Jr. , and dated June 25, 1914.)
